1. Opening, Present and Apologies

2. Confirmation of the Minutes

4. Treasurer's Report

ANNUAL REPORT
2009

2009 has been a period of transition for the City of Sydney Law Society. With Anthony Restuccia our long-serving President for the previous three years standing down, a new President, Emeritus Professor David Barker AM was elected after the Annual General Meeting in November 2008. The other Office Bearers retained their positions – John Newton, Vice-President, Nea Goodman, Treasurer and Ken Harkness, Secretary. Anthony Restuccia replaced Victor Berger as Immediate Past President.

The Society continued to operate a weekly free Continuing Legal Education Programme, the Seminars being held at the Sydney Mechanics School of Arts, with attendance averaging approximately 40 members per session. The success for this programme must be attributed to Ken Harkness, the Society's Secretary and CLE Convenor, who has managed the booking of weekly presenters who have all given their services on a pro-bono basis. A most important outcome of this programme has been an increase in the Society's membership which reached 325 financial members at the end of the 2008/2009 year. It would appear that this number will be increased in the current financial year.

One of the Society's main social events was the Law Week Breakfast which was held at the City Tattersalls Club on 11th May. The focus for the Breakfast was the issue of the negative public perception of the law and lawyers. Christopher Roper AM, Director of the St. James' Centre, presided over a discussion of presenters consisting of James Eyers, the Legal Editor of the Australian Financial Review, Laura MacIntyre, Senior Reporter of Lawyers Weekly, and Maria Ianotti the NSW Law Society's Media Adviser. We were also pleased to welcome Joe Catanzariti, the President of the NSW Law Society, Michael Tidball, the Society's Chief Executive Officer and Anna Katzmann, the President of the NSW Bar Association. The Society was grateful for the efforts of Colleen Donnelly, a member of the Committee who was the convener for the Breakfast, assisted by our Vice-President, John Newton. The Society's efforts with regard to the Breakfast were recognised by the presentation to our President David Barker of a Highly Commended Award by Joe Catanzariti at a subsequent meeting of Regional Presidents on the 30th July.

The Committee has been determined to use this year as an opportunity to plan for the future of the Society. With the help of a grant of \$800 from the NSW Law Society Regional Society's Fund, Sue-Ella Prodonovitch of WHK Horwarth was engaged to conduct an afternoon/evening Planning Workshop on the 10th June to examine current activities and plan for future opportunities available to the Society. The major outcomes of this Workshop have been an upgrading of the image of the Society ranging from its stationery, logo, brochures and sponsorship, to the future venue and presentation of its CLE Seminars.

Other social activities of the Society have been a CSLS Table at the NSW Law Society's 125th Anniversary Dinner on the 30th July, the re-launching of the Newsletter with a changed format under the editorship of Nea Goodman, a record attendance of 163 at the Cocktail Party on the 16th October as well as the AGM and formal Dinner on the 19th November.

The Society has continued to be responsible for the operation of the Downing Centre Pro Bono Room under the auspices of its Convenor Anthony Restuccia, who is now assisted by

Stephen Bell as Deputy Convenor. The Committee has agreed to appoint a Sub-Committee consisting of Anthony Restuccia, Stephen Bell, Colleen Donnelly and Ken Harkness to review the operation of this service and to make any necessary recommendations for its enhancement. In this connection, arrangements are being made to install an on-line provision for participating solicitors.

The Society was advised by one of its Committee members Denis Mockler that he was in possession of fifteen boxes containing the records of the Society and that it would be appropriate for arrangements for the preservation of these records. The outcome has been that the Society is engaging a professional Archivist to advise on the review and make recommendations as to the future archiving of these records.

Before closing this Report it is appropriate that I should pay tribute to the hard work undertaken by all the office bearers, particularly the Vice President, John Newton, Treasurer, Nea Goodman and our Secretary Ken Harkness, together with Pam Suttor, our 'Paired' Member of the Law Society Council. Mention should also be made of the contribution by the Society's Committee who have met on a regular monthly basis and given sterling support to the activities of the Society.

In conclusion the thanks of all members of the Society must be given to Ann Parisi, our Administrator, who has working unstintingly for the interests of the CSLS, in the administrative arrangements for the Newsletter, Committee meetings, social activities, membership and payment of accounts. We all recognise that without her effort the success of the Society this year would have been much harder to achieve.

Treasurer's Report 2008/2009

I report on the financial position of the City of Sydney Law Society for the year ended 30 June, 2009. Copies of signed audited accounts are circulated. The auditors are the same as last year, Lowy Wilcock & Co, Chartered Accountants 72 Pitt Street Sydney.

The accounts reflect the policy position of the Committee that CLE and forums should be free to members, as a benefit and service. As a consequence of this policy income from activities and non member has remained stable. Sponsorship in past years has been available, and the Committee endeavoured to meet sponsors needs. Income from "spot sponsors" has been limited and it is likely this situation will continue in 2009/2010.

The Committee receives no funding for administrative support or CLE from the Law Society of NSW, save for a minor contribution to the cost of Law Week Breakfast. In the 2008/2009 the Committee retained a book keeper to manage MYOB and this has enhanced the quality of financial reports being presented to the Committee. During the year 2008/2009.

Expenses remain steady. Secretarial/administration support continues to be the largest expense. Given 54% of the profession is in the CBD and number of activities organised by the Committee it is and remains unrealistic to expect members or their firms to contribute large amounts of time or premises to assist running CSLS.

The accounts for income and expenditure for the year ended 30.6.2009 disclose:

1. Total income for the year was \$43,125.66 compared to \$52,473.64 for the year ended 30.6.2008.
2. Total expenditure for the year was \$40,807.02 compared to \$49,488.74 for the year ended 30.6.2008.

Accordingly I report a profit of \$1,623.40 (after tax) compared to a profit last year of \$2,089.40 (after tax). Retained profits for the year ended 30.6.2009 are \$50,670.47 (up from \$49,047.23 for the year ended 30.6.2008)

Monthly bank reconciliations, financial statements, profit and loss statements and accounts to be paid are circulated at each Committee meeting together with number of attendees at each function held during the preceding month.

The voluntary assistance of members of the Committee and their firms is much appreciated and I thank the President, Vice President, Immediate Past President and Secretary for support and assistance during the past year. I have special thanks for Ann Parisi, our secretariat and administration power house – thank you.

The principal activities of the association during the financial year were: continuing legal professional education.

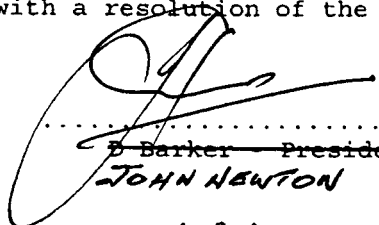

1 Statement of Significant Accounting Policies

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act 1984 of New South Wales. The committee has determined that the association is not a reporting entity.

This financial report has been prepared in accordance with the requirement of the Associations Incorporation Act 1984 of New South Wales and the following Australian Accounting Standards:

No other Australian Accounting Standards, Australian Accounting Interpretations or other authoritative pronouncements of the Australian Accounting Standards Board have been applied.

The financial report has been prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following material accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

a. Income Tax

The change for current income tax expenses is based on the profit for the year adjusted for any non-assessable or disallowed items. It is calculated using tax rates that have been enacted or are substantively enacted by the balance sheet date.

b. Fixed Assets

Property, plant and equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciation amount of all fixed assets are depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.
